NOTICE OF TRUSTEE VACANCY

Due to the resignation of Trustee Eli Gough, representing Zone 2, on the evening of August 8, 2023, the Board of Trustees of Shoshone Joint School District declared a vacancy for Zone 2 on August 8, 2023 and is commencing the process to fill this vacancy.

Zone 2 Encompasses: BEGINNING at the U.S. Highway 93 and South School District Boundary and the Lincoln-Jerome County Line, thence Northerly along State Highway 93 approximately 5.5 miles to the South Shoshone City Limits Line, thence Easterly along Shoshone City Limits approximately 890 feet, thence Northerly along Shoshone City Limits approximately 350 feet along Shoshone City Limits to State Highway 24 (Dietrich Highway) and Beverly Street, thence Northeasterly along Beverly Street to Rail Street East, thence Northwesterly along Rail Street East to Greenwood Street (State Highway 75), thence Northeasterly along Greenwood Street (State Highway 75) to right (Northerly) bank of the Little Wood River, thence Southeasterly along right (Northerly) bank of the Little Wood River to Beverly Street, thence Northerly along Beverly Street to 3rd Street, thence Westerly along 3rd Street to Cherry Street, thence Northerly along Cherry Street to 4th Street, thence Westerly along 4th Street to Elm Street, thence Northwesterly along Elm Street to 5th Street, thence Westerly along 5th Street to Grape Street, thence Southerly along Grape Street to right (Northerly) bank of the Little Wood River, thence Southwesterly along right bank of the Little Wood River approximately 260 feet to west Shoshone City Limits, thence Southwesterly along Shoshone City Limits approximately 540 feet to U.S. Highway 26, thence Westerly along U.S. Highway 26 approximately 4.1 miles to the School District Boundary being on the East line of Section 36, Township 5 South, Range 16 East, B.M., thence Southerly then Westerly along School District Boundary to US Highway 26, thence leaving the School District Boundary Southwesterly along US Highway 26 to West School District Boundary, thence Southerly then Easterly along School District Boundary to State Highway 93 and the Lincoln-Jerome County Line being the **POINT OF BEGINNING**.

The individual selected to fill this term will serve the balance of the unexpired term currently ending on December 31, 2023.

The Board of Trustees has a period of 90 days from the declaration of the vacancy to fill this position with a qualified individual who resides in Zone 2. If this does not occur, the Board may appoint a person at-large from within the boundaries of the school district. Otherwise, after 120 days, the appointment shall be made by the Board of the County Commissioners.

The process that will be utilized by the Board of Trustees to fill this vacancy shall be: interested parties that live in Zone 2 (after 90 days within the boundaries of the school district) shall submit a letter of interest to either the Clerk of the Board, or the Superintendent of Shoshone School District.
