Easterly along Shoshone City Limits Line approximately 890 feet, thence

Northerly along Shoshone City Limits Line approximately 350 feet to State Highway 24 (Dietrich Highway) and Beverly Street, thence leaving said City Limits Line

Northeasterly along Beverly Street to Rail Street East, thence

Northwesterly along Rail Street East to Greenwood Street (State Highway 75), thence

Northerly along Shoshone City Limits approximately 350 feet along Shoshone City Limits to State Highway 24 (Dietrich Highway) and Beverly Street, thence

Northeasterly along Beverly Street to Rail Street East, thence

Northwesterly along Rail Street East to Greenwood Street (State Highway 75), thence

Northeasterly along Greenwood Street (State Highway 75) to right (Northerly) bank of the Little Wood River, thence

Southeasterly along right (Northerly) bank of the Little Wood River to Beverly Street, thence

Northerly along Beverly Street to 3<sup>rd</sup> Street, thence

Westerly along 3<sup>rd</sup> Street to Cherry Street, thence

Northerly along Cherry Street to 4<sup>th</sup> Street, thence

Westerly along 4<sup>th</sup> Street to Elm Street, thence

Northwesterly along Elm Street to 5<sup>th</sup> Street, thence

Northerly along Elm Street to 5<sup>th</sup> Street, thence  
Westerly along 5<sup>th</sup> Street to Grape Street, thence  
Southerly along Grape Street to right (Northerly) bank of the Little Wood River, thence  
Southwesterly along right (Northerly) bank of the Little Wood River approximately 260  
feet to west Shoshone City Limits, thence  
Northerly, then Easterly, then Southerly, then Easterly following Shoshone City Limits  
Line to State Highway 75, thence leaving said City Limits Line  
Southwesterly along State Highway 75 (Greenwood Street) approximately 165 feet to  
6<sup>th</sup> Street, thence

Westerly approximately 700 feet to the Big Wood River, thence

Southerly then Westerly along Big Wood River to State Highway 75, thence

Northerly then Northeasterly along State Highway 75 to the North School District Boundary, thence

Easterly then Southerly along said School District Boundary to said Unnamed Two-Track and the East School District Boundary being approximately 300 feet north of the Southeast corner, of the Southwest  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 11, Township 4 South, Range 18 East, Boise Meridian and to the **POINT OF BEGINNING**.
